

TERMS AND CONDITIONS

1. Introduction. PLEASE READ THE FOLLOWING TERMS AND CONDITIONS CAREFULLY BEFORE USING THE SERVICES PROVIDED IN THE SITE. BY CLICKING THE ACCEPTANCE BUTTON AND / OR USING ANY OF THE SERVICES PROVIDED IN THE SITE, YOU ARE CONSENTING TO BE BOUND BY AND ARE BECOMING A PARTY TO THIS AGREEMENT. IF YOU DO NOT AGREE TO ALL OF THE TERMS OF THIS AGREEMENT, CLICK THE BUTTON THAT INDICATES YOU DO NOT ACCEPT THE TERMS, AND SIMPLY LOG OUT OF THE SITE.

2. Certain Definitions. The following definitions apply to this Agreement:

"Dragnet" refers to Dragnet Solutions Limited (owner and operator of Alumni Jobs Portal), all its affiliates and subsidiaries.

"Dragnet Materials" includes any materials, methodologies, implementation plans or other intellectual property used during the provision of the Services.

"the Site" means "Alumni Jobs Portal" under **Dragnet's** control, whether partial or otherwise.

"Alumni Jobs Portal" means **"the site"**.

"Employer Materials" includes any brochures, emails, sample job postings, web site content, career fair material, audio, videos, photographs, logos, trademarks, service marks, domain names, documents or other materials provided by Employer, if any, for use in connection with the Services.

"Job Seeker" means a User who is accessing this Site to search for a job or in any other capacity except as an Employer.

"Services" means any services provided by Dragnet or its agents described herein.

"User" refers to any individual or entity that uses any aspect of the Site.

"You" or "you" means the person who is agreeing to these Terms and Conditions.

3. Intellectual Property Rights and Acceptable Use of the Sites and Services.

3.1 General Use Rules. Alumni Jobs Portal is intended for students, interns and all members of alumni of a particular tertiary institution seeking full time, part time and or internship employment and for employers or recruiters seeking students, interns and or members of alumni of a particular institution for employment. You may use the Site only for lawful purposes within the stated context of Dragnet's intended and acceptable use of the Site.
